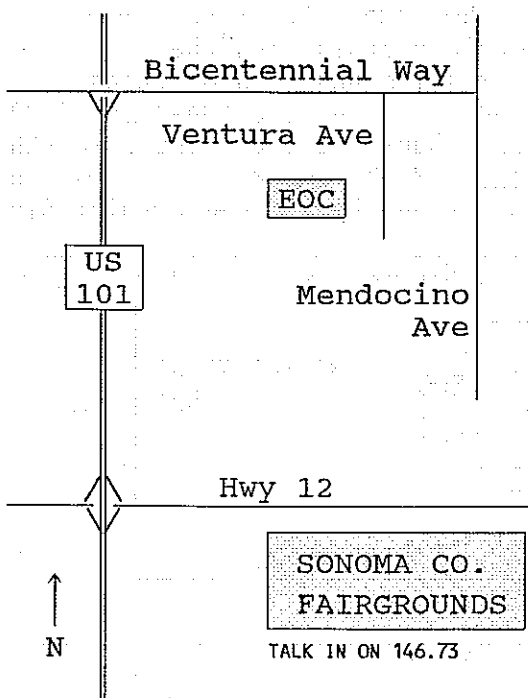
**VENDORS:** Bring your own table if you need one. You can start setting up anytime after 7 AM. Spaces are \$5 in advance or \$7 at the door.

Continue north on Hwy 101 and exit right on Bicentennial Way. Turn right at the first traffic light onto Ventura. The EOC is about 1/4 mile on the right. Look for the radio towers.

Pre-registration for exams is strongly recommended. Send a photocopy of your license (if any), a completed 610 form, and a check for \$4.75 made out to "ARRL-VEC" to Steve Lund WA8LLY, 10180 Mill Station Rd., Sebastopol, CA 95472. Written exams start at 1 PM. **ON EXAM DAY** bring: **ORIGINAL** license, Photo ID (CA driver's license preferred), 2 soft-lead pencils, pen, and a calculator. 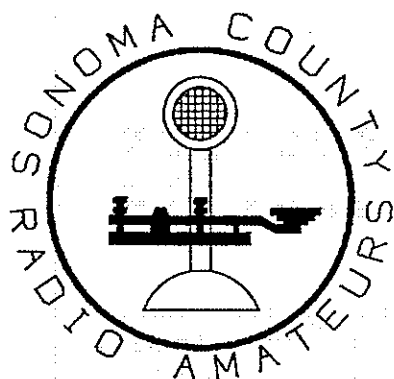

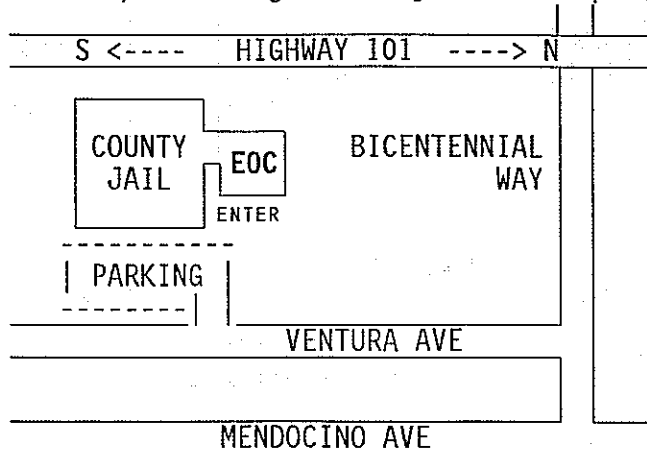

IN SHORT SKIP



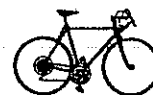

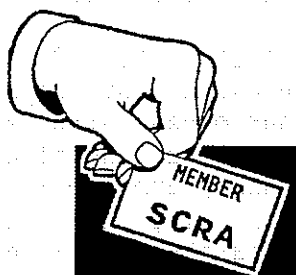

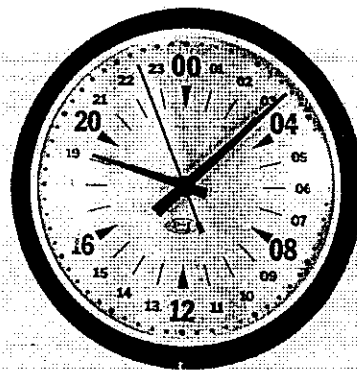


NEWS of Amateur Radio

**A JOINT EAST-WEST HAM SATELLITE** will be launched in mid 1990. AMSAT-DL in West Germany and the Soviet amateur satellite organization ORBITA have a tentative agreement to launch a RUDAK satellite aboard the Russian RS-14 launch vehicle. RUDAK-2 will have AX.25 packet capability so that digipeating and limited mailbox operation will be possible. Tnx *Westlink* Report.

**RECALIBRATE THAT HEATHKIT VTVM.** As of January 1, 1990, the National Bureau of Standards will be adjusting the standard volt 9.2 parts per million and the standard Ohm 1.7 ppm. These correspond to .00092% and .00017%, respectively. *Westlink*

**PRB-1 WORKS FOR MESA HAMS.** 75-foot towers are now legal in Mesa AZ following 6 months of negotiations between Mesa City staff and the Superstition ARC. Assistance came from ARRL Volunteer Counsel Neil Wake KV70, Sen. Barry Goldwater K7UGA, the Am. Red Cross, Maricopa County CD & Emergency Services, US Army MARS, and many more. Tnx *ARRL Letter*

## NOSTALGIA (Tnx Unix Notes)

I laughed so hard I almost shorted an antler when mbutts@mentor.com (Mike Butts) said,

"I wish some enterprise would put out an old ham radio [equipment] calendar... They would find no shortage of candidates. Collins, Hallicrafters, the National HRO-500, the Johnsons, the Hammarlund HQs, Heath, Drake, you know what I mean. I'd pay \$15 or \$20 for one that I could hang in my office all year. It might make a good fundraiser for some needy cause (like ARRL?)"

I love it, Mike. And here are some candidates for the first year (and then some):

- Heathkit AT-1 transmitter (Heath's FIRST, with 50 smokin' watts of raw 6L6 CW power on 80, 40, and 15, all for under 30 bucks - the quintessential Novice rig for the rest of us)!
- Johnson Ranger transmitter (the quintessential Novice rig for RICH kids)!
- Heathkit GD-1 grid dip meter (complete with the 5 plug-in coils and coil holder)!
- Heathkit VF-1 VFO (but not until you get your General, boy)!
- Heathkit DX-100 transmitter (you can't afford it, but your rich cousin has one). The pre-CB 11-meter coil is easily converted to 6 meters, but you don't bother because you're soon building your very own:
- Johnson 6N2 transmitter (goodbye, General - hello, Technician, and welcome to the wonderful world of post-Novice QRO VHF)!
- Hallicrafter SX-43 receiver (cool if only because they looked like the radios you used to see them using in WWII movies to listen to dogfights between P-40s and Zeros over Burma - complete with the wood speaker enclosure with the "H" cutout)!
- National SW-54 receiver (the SWL's standby - WWV on a good night)!
- National NC-98 receiver (the SWL's aspiration - Radio Moscow on a good night, and Sputnik on a good morning)!

■ Hammarlund HQ-110 receiver (forget about it but your rich cousin has one of these, too)!

■ Collins 75A1/2/3/4 receiver (nobody you know even knows anyone who actually OWNS a 75A4 - you're positive someone makes phony Collins face plates to cover up HQ-110's for those fuzzy shack pictures you see in QST.)

■ Gonset 2-meter (and/or 6-meter) transceiver (the grey classic - 6 watts of AM, complete with handle, four crystals, noise squelch you never used, all four megacycles [I mean, megzHERTZ, sorry...] of the band squeezed into a two-inch dial, and a burgundy rcv/xmit lever switch that could've come straight off a Dictaphone.) And one morning about eight years later, the year you go off to college, the great circle closes in its cosmic way: Before your next renewal comes up, you walk out of a graveyard shift in a mainframe computer room on Long Island in a daze, and God tells you to drive down to the FCC office on Christopher Street in Manhattan and take your Extra Class exam cold, and you do, and 20 years later you're a QCWA old-timer with a two-letter call.

I don't know where the Gonset rigs went, but from the first rainy day in the back of our local TV repairman's shop when I was 12 years old, when I watched him use one to work some guy about three miles away in Brooklyn on 2M phone, I resolved to get my Novice ticket. And the hum of the transformer, and the smell of the burning phenolic, and the glow of those 826s, and

the 5x9 from the guy in Brooklyn, got me through an awful lot of nights of wondering whether five years of electrical engineering with a bunch of guys who still wouldn't know a 6L6 from a 6-pack when they graduated was worth it.

And to tell you the truth - as I sit here pounding a Wyse 60 connected to a 386 PC working more usenet DX at a keystroke than I ever did on 20 CW - I don't know if a Yaesu HT would have the same effect on me all over again today. They just don't smell the same.

But I'd sure pay a lot to have a calendar with a photo of the OM's '56 Buick with that ridiculous 6-meter HALO antenna cruising down Greenpoint Avenue.

## Letters to Westlink Report

### HRO to ARRL: No on No-Code!

Westlink Report has obtained a copy of the following letter, sent by the management of the Ham Radio Outlet store chain to all ARRL directors. It is presented here in its entirety, unedited.

June 15, 1989

Dear Directors,

You will decide whether the ARRL will endorse the recommendations of your "No-Code" committee. We have some concerns that need to be brought to your attention.

The amateur radio fraternity has the impression that the No Code movement is an industry ploy designed to simply increase sales without regard to the long-term good of the hobby. For example, why was Radio Shack suddenly SO interested in the idea of No Code? What ulterior motive could they have?? How/why was Radio Shack chosen to represent the amateur radio industry on your committee? How much experience does Radio Shack have in amateur radio other than their controversial 10 meter mobile??

Secondly, look at the committee proposal recommending 200 kHz of 2 meters to packet only.... Now look at the other industry representative on your committee...AEA...enough said!!

Thirdly, the *CQ Magazine* reader survey results may NOT be representative of the actual overall amateur population. Remember, those surveyed are *CQ's* subscribers, who have been subjected to editorial after editorial about how "serious" the "problems" are within amateur radio, and how the No Code license is the "cure." We have taken our own random survey in some of our stores and are finding sentiment to be 60% OPPOSED to the idea of No Code. Local radio clubs are polling their members. The Palo Alto ARC recently voted 40 AGAINST, 4 in favor. What REALLY is the consensus of the amateur population?

We are opposed to the No Code proposal as presented by your committee. We feel the inclusion of 2 meters is a major mistake. Actually, is a No Code license necessary? Our numbers are GROWING at 3.3% per year: that is very controlled healthy growth. A No Code license is not going to attract thousands of teen-agers. Today's youth is fascinated by the "high technology" of the computer field, not ham radio. The people attracted to ham radio today are the sailboaters, the engineer types, SWLers and the retirees. Our hobby has simply matured, and as we see it there is no turning back.

Please don't get caught up in the "HYPE" that our hobby is dying off, and we're going to lose all of our frequencies, and the end is near. An influx of 100,000 new "hams" (dreamer) will, in all likelihood, not sway the FCC one way or another. True, we may lose a portion of a band now and then (220 Mhz), but please remember, we have recently acquired 10, 18, 24 and 902 MHz., none of which have been activated to any extent. In closing, we ask that you NOT endorse the findings of your committee. We suggest you bring the proposal more in line with the desires of your members. Look closely at the 2 meter allocations which definitely are opposed by the majority.

Please review the unsuccessful Canadian No Code License. We are fearful that "selling out" to certain commercial interests who originated the "No Code" proposals will do irreparable harm to a hobby that has brought much joy to all of us. You will find only a select group of commercial interests are actually in favor of No Code as suggested by the steering committee. Many others, including Ham Radio Outlet, stand firmly opposed.

We are fearful that "selling out" to those who are unwilling to take the time to learn the code would be a mistake. You would remove the one basic thing that has always held the amateur radio operator apart from the rest of the community, the knowledge of the Morse Code. Please, don't be fooled into making a mistake that could change our hobby in a negative way forever.

6. Observe communications procedures and discipline.
7. Brief your relief as you would want to be briefed.
8. Complete necessary forms and record keeping.

THE MOST IMPORTANT ASPECT OF WORKING WITH OTHER MEMBERS OF THE ICS ORGANIZATION IS MAINTAINING A GOOD WORKING RELATIONSHIP BY KEEPING THE COMMUNICATIONS CHANNELS OPEN.

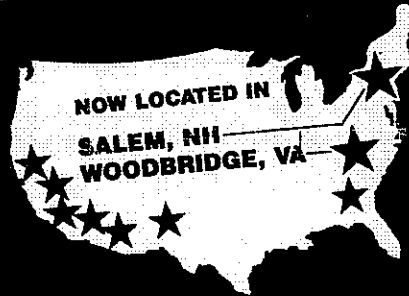
