





## **NEW NAMES FOR** FORMER SOVIET REPUBLICS

Five newly-independent former Soviet republics have altered the preferred English language spelling of their names. The U.S. government will henceforth use the new spelling, as will American wire services, most U.S. newspapers, news magazines and broadcast media.

## FOSTER CITY COURT CASE

The following is a packet message I asked Rusty if I could quote. The result of the court decision affects many of us. de Bill N6GHG

Many of you have been following WD6CJB's legal battle against CC&Rs in Foster City. On Mar 5 we had oral arguments before the Calif. Court of Appeal; on Mar 19 the Court issued its ruling. As we said before, "it ain't over 'till the fat lady sings," and she has NOT yet sung!

First the bad news: The Court of Appeal did not like our argument that PRB-1 could preempt enforcement of private CC&Rs, and they REVERSED the holding of the San Mateo County Superior Court which had ruled in WD6CJB's favor on that basis. Although disappointing, this came as no surprise to us -during oral arguments the Court had been extremely hostile toward this argument.

Now the good news: In a completely unexpected move, the Court of Appeal remanded the case (i.e., sent it back) to the San Mateo County Superior Court for further proceedings. The Court of Appeal said "Reversal [based on PRB-1 preemption), however, does not imply that the trial court must necessarily enforce the restrictions in full. ... The trial court has the equitable power to refuse enforcement if it finds the restriction so unreasonable as to violate public policy. Promises [CC&Rs] restricting the use of land are unreasonable and, therefore, illegal when the harm caused by the restriction is so disproportionate to the benefit produced by the performance of the promise that the promise ought not to be enforced."

The net of all this appears to be that the Court of Appeal did not like the REASON why WD6CJB won the first time around, but they might have liked the fact that he won. They've now sent the case back, giving the trial judge a new reason, acceptable to them, on which WD6CJB again could prevail. It will be up to us, of course, to now provide the trial judge with proof of the unreasonableness of the Foster City CC&Rs. That's going to take some work, and we'll determine our exact strategy over the next couple of weeks.

Again, thank you all for the great support and encouragement you've given us in this case. Stay tuned though -- more is sure to follow!! 73 de Rustv. W60AT

The PROGRAM was a talk by N1AL on Radio Frequency Interference. It gave Alachance to flack his new book.



#### by Al Bloom N1AL


After 15 years of driving my beat-up VW, I finally broke down and bought a real car. After transferring the call-letter license plates, my first thought was to re-install the Drake UV-3 3-band radio in the new buggy. It only took me 3 years to get around to it!


Since I had the remote-control head option for the UV-3, I decided early on to mount the radio in the trunk. The question was: what to do for antennas? I had no great desire to drill three holes in the car to accommodate 144, 220 and 440 MHz whips.

My "new" car (an '87 Accura Legend) has one of those fancy electric antennas mounted on the rear deck. I built a combination switchbox and matching network to allow the antenna to be used on AM, FM, and the three amateur bands. Since the UV-3 has an auxiliary connector with +5V signals that come on when each band is selected, I used 5V reed relays to switch the antenna. While I was at it, I wired the +12V from the radio into the electric antenna so it will pop up whenever the ham radio is turned on.

The antenna still works with the car stereo when the UV-3 is off. (Actually, the stereo auto-switches to the rearwindow antenna when the whip antenna is unavailable.)

With the glove box shut, there is no visible indication that there is a 2-way radio in the car, other than the speaker mounted on the center console. Hopefully this will deter break-ins.


